

### RULES AND REGULATIONS OF THE ASSOCIATION

1. NAME OF THE SOCIETY: SPHURTHI FOUNDATION

2. ADDRESS: Door.No:12/49 (New D. No. 55/41),

Pedda Chowtapalli, Ravindra Nagar Kadapa - 516003,

Andhra Pradesh State.

3. JURISDICTION: Entire Andhra Pradesh State

#### 4. MEMBERSHIP

a) Any person who wishes to join the society shall pay Rs. 1000/- as admission fees and also subscription of Rs. 50/- per month shall be admitted to the Society, when the executive committee approves it. A member shall loose his / her membership on one's death or one's absence without permission for three consecutive meetings or on resignation or removed by executive committee.

#### b) TERMINATION OF MEMBERSHIP:

By the Death or Resignation, by become of unsound mind, by not receiving the Membership by paying the request fee within the three month from the end of the each official year. #### 2. VICE PRESIDENT:


