School, Alamkhanpalli (Vi), Kadapa Mandal, YSR District has applied for grant of Provisional Recognition for classes I to VII (EM) for the academic years 2019 – 2020 to 2028 - 2029 under the Management of “Sphurthi Foundation, 12/49, Pedda Chowtapalli, Ravindranagar, Kadapa, YSR District”.

The Inspecting Officer i.e., Mandal Educational Officer, Kadapa caused inspection and submitted his report in the reference 6th read above.

In exercise of powers conferred by the G.Os 1st to 5th read above and in view of the circumstances explained in the reference 6th read above, and after careful examination of the proposals of the Society and also the inspection report of the Inspecting Officers in the reference 6th read above, permission is hereby accorded for grant of Provisional Recognition in respect of Kadapa E.M. School, Alamkhanpalli (Vi), Kadapa Mandal, YSR District for classes I to VII (EM) with one section in each class for the academic years under the management of “Sphurthi Foundation, 12/49, Pedda Chowtapalli, Ravindranagar, Kadapa, YSR District” without aid now or in future subject to fulfillment of the following conditions.

- 1) That the society shall abide the rules and regulations made in the Govt. orders 1st to 4th read above and to the conditions in the reference 5th read above.
- 2) That the society shall apply for Renewal of Recognition well before the expiry of the recognition now granted by following the time schedule given in G.O. Ms. No. 1 dated: 01.01.1994.
- 3) That the Society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking water facilities, Furniture, Library, Laboratory equipment, Play field, required staff as per the Staff pattern and other facilities are necessary before approach the competent authority.
- 4) That this permission does not confer any right on the society for claiming recognition.
- 5) That the permission is accorded to “Sphurthi Foundation, 12/49, Pedda Chowtapalli, Ravindranagar, Kadapa, YSR District” and no other society or body can open a School on their behalf.
- 6) The permission is accorded to open the School premises in the locality and there shall not be any change in the premises of locality.
- 7) The society shall provide the necessary material even if it costs more than the deposit amount.
- 8) The Society shall renew the No objection Certificate of the Department of Fire Services soon after expiry of the No Objection Certificate.
- 9) Those Teachers who are working in Private Schools without possessing pass TET being conducted by the Andhra Pradesh School Education Department should invariably attend the TET and the managements should confirm their appointment only after passing the TET along with their regular qualification of D. Ed. / B. Ed, and other conditions stipulated by the Government from time to time.

- 10) The Management should ensure to pay the minimum salaries to the Teachers by 1st of every month through bank.
- 11) The Management should ensure to reach every benefit like Gratuity, Teachers Provident Fund, Group Insurance Scheme etc., to the Teachers and other staff as per Rule 18 of G.O. Ms. No. 1 Education Department, dated: 01.01.1994.
- 12) The Management should issue Identification cards to the staff working in their school.
- 13) The Management should submit their Annual Administration Report in the prescribed proforma to the competent authority for every financial year by the 30th September.
- 14) The Inspecting Authority (Mandal Educational Officer) inspect and verify the accounts including payment of the salaries and other benefits like Gratuity, Teachers Provident Fund, Group Insurance Schemes etc., to the staff.
- 15) The Management should upload the fee to be collected by them for the academic year 2019 – 2020 in CSE.AP.GOV.IN website and also display in two prominent places visible to public in school premises.

In exercise of powers conferred by the G.Os 1st to 5th read above and in view of the circumstances explained in the reference 6th read above, and after careful examination of the proposals of the Society and also the inspection report of the Inspecting Officers in the reference 6th read above, permission is hereby accorded for opening of a new Upper Primary School in the name of Kadapa E.M. School, Alamkhanpalli (Vi), Kadapa Mandal, YSR District with classes I to VII (EM) with one section in each class under the management of “Sphurthi Foundation, 12/49, Pedda Chowtapalli, Ravindranagar, Kadapa, YSR District” without aid now or in future subject to fulfillment of the following conditions.

- 1) That the society shall abide to the rules and regulations made in the Govt. orders 1st to 4th cited above.
- 2) That the society shall apply for recognition by 31st August at the latest duly fulfilling the conditions.
- 3) That the Society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking water facilities, Furniture, Library, Laboratory equipment, Play field, required staff as per the Staff pattern and other facilities are necessary before approach the competent authority.
- 4) That the permission accorded is restricted to this year only and it is not valid for the subsequent academic year.
- 5) That this permission does not confer any right on the society for claiming recognition.
- 6) That the permission is accorded to “Sphurthi Foundation, 12/49, Pedda Chowtapalli, Ravindranagar, Kadapa, YSR District” and no other society or body can open a School on their behalf.
- 7) The permission is accorded to open the School premises in the locality and there shall not be any change in the premises of locality.


- 8) The society shall provide the necessary material even if it costs more than the deposit amount.
- 9) The Society shall submit the No objection Certificate from the Department of Fire Services while submitting the proposals for grant of provisional recognition, if failed so, the District Educational Officer, YSR District is liable to withdraw the permission without any prior notice.
- 10) Those Teachers who are working in Private Schools without possessing pass TET being conducted by the Andhra Pradesh School Education Department should invariably attend the TET and the managements should confirm their appointment only after passing the TET along with their regular qualification of D. Ed. / B. Ed, and other conditions stipulated by the Government from time to time.
- 11) Management should ensure to pay the minimum salaries to the Teachers by 1st of every month through bank.
- 12) All the Managements should ensure to reach every benefits like Gratuity, Teachers Provident Fund, Group Insurance Scheme etc., to the Teachers and other staff as per Rule 18 of G.O. Ms. No. 1 Education Department, dated: 01.01.1994.
- 13) All the Management should issue Identification cards to the staff working in their schools.
- 14) All the Managements should submit their Annual Administration Report in the prescribed proforma to the competent authority for every financial year by the 30th September.
- 15) The Inspecting Authority (Deputy Educational Officer/Mandal Educational Officer) inspect and verify the accounts including payment of the salaries and other benefits like Gratuity, Teachers Provident Fund, Group Insurance Schemes etc., to the staff.
- 16) The management should upload the fee collected by them during the academic year 2019 – 20 in CSE.AP.GOV.IN website.
- 17) The Management should also upload the fee to be collected by them for the academic year 2019 – 2020 in CSE.AP.GOV.IN website and also display in two prominent places visible to public in respective school premises.
